CASE SUMMARY

In the Statement of Claim, as amended, Claimants alleged that Respondents recommended a variable annuity that was contrary with their investment objectives.

Unless specifically admitted in the Statement of Answer, JPM, Davis, Leister, and Simpson denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

Unless specifically admitted in the Statement of Answer, Minerd denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

Unless specifically admitted in the Statement of Answer, Weiss denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

Unless specifically admitted in the Statement of Answer, White denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

RELIEF REQUESTED

In the Statement of Claim, as amended, Claimants requested \$50,000.00 in damages.

In the Statement of Answer, JPM, Davis, Leister, and Simpson requested that all claims asserted against them be dismissed with prejudice and an award rendered in their favor; that all

FINRA fees be assessed to Claimants; and that they be awarded any other relief that the Arbitrator deems just and proper.

In the Statement of Answer, Minerd requested that all claims against her in the Statement of Claim be dismissed and that she be awarded her costs in responding to this claim, including attorneys' fees.

In the Statement of Answer, Weiss requested that all claims against him in the Statement of Claim be dismissed and that he be awarded her costs in responding to this claim, including attorneys' fees.

In the Statement of Answer, White requested that all claims against him in the Statement of Claim be dismissed and that he be awarded her costs in responding to this claim, including attorneys' fees.

OTHER ISSUES CONSIDERED AND DECIDED

The Arbitrator acknowledges having read the pleadings and other materials filed by the parties.

Nationwide Life Insurance Company is not a member or associated person of FINRA and did not voluntarily submit to arbitration. Therefore, the Arbitrator made no determination with respect to the claims against Nationwide Life Insurance Company.

AWARD

After considering the pleadings, the Arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows:

- 1. Claimants' claims are denied in their entirety.
- 2. FINRA Dispute Resolution Services shall retain the \$600.00 filing fee that Claimants deposited previously.
- 3. Respondents are jointly and severally liable for and shall pay to Claimants \$300.00 to reimburse Claimants for 50% of the filing fee previously paid to FINRA Dispute Resolution Services.
- 4. Any and all relief not specifically addressed herein, including requests for punitive damages and attorneys' fees, if any, are denied.

FEES

Pursuant to the Code, JPM has paid to FINRA Dispute Resolution Services the \$750.00 Member Surcharge and \$1750.00 Member Process Fee previously invoiced.
