Statement of Answer filed by Respondent on or about: June 25, 2021.

Respondent signed the Submission Agreement: June 24, 2021.

RMI did not file a Statement of Answer or sign the Submission Agreement.

CASE SUMMARY

In the Statement of Claim, Claimant asserted the following causes of action: violation of the Illinois Consumer Fraud and Deceptive Business Practices Act, fraudulent misrepresentation, and negligent misrepresentation. The causes of action related to allegations that, on January

28, 2021, Claimant was restricted from purchasing AMC Entertainment Holdings (AMC) stock and his position in Nokia Oyj (NOK) was harmed as a result, and the restriction illustrates the false, deceptive, and misleading nature of Respondent and RMI's marketing regarding unlimited trades.

Unless specifically admitted in the Statement of Answer, Respondent denied the allegations made in the Statement of Claim and asserted various affirmative defenses.

RELIEF REQUESTED

In the Statement of Claim, Claimant requested actual damages of \$1,667.00, costs and reasonable attorneys' fees, punitive damages, injunctive relief, declaratory judgment, and other monetary relief as the Arbitrator deems just and equitable.

In the Statement of Answer, Respondent requested that the Statement of Claim be dismissed in its entirety with prejudice and such other and further relief as may be just and proper.

OTHER ISSUES CONSIDERED AND DECIDED

The Arbitrator acknowledges having read the pleadings and other materials filed by the parties.

RMI is not a member or associated person of FINRA and did not voluntarily submit to arbitration. Therefore, the Arbitrator made no determination with respect to the claims against RMI.

<u>AWARD</u>

After considering the pleadings, the Arbitrator has decided and determined in full and final resolution of the issues submitted for determination as follows:

- 1. Claimant's claims are denied in their entirety.
- 2. FINRA Dispute Resolution Services shall retain the \$75.00 filing fee that Claimant deposited previously.
- 3. Any and all claims for relief not specifically addressed herein, including any requests for punitive damages, treble damages, and attorneys' fees, are denied.
